# MINUTES OF COUNCIL MEETING HELD ON TUESDAY 23<sup>RD</sup> MARCH 2021 AT 7.30PM, REMOTELY VIA ZOOM

- 123/2021 **PRESENT & APOLOGIES FOR ABSENCE** all present.
- 124/2021 **DISCLOSURE OF PECUNIARY INTERESTS** none.
- 125/2021 **DISPENSATION REQUESTS** none.
- 126/2021 **PUBLIC PARTICIPATION SESSION** the applicant spoke regarding 21/05004/FUL. The building is currently underused was stables and storage and beginning to decay and keen to bring it back into use as ancillary accommodation.

Cllr. Davies asked how issues re access and disruption during construction will be addressed? Applicant has contacted neighbours by letter to engage them in dialogue – currently neighbours are supportive. Site has offroad access so won't be vehicles parked on road but will be some temporary increase in traffic on Mill Lane.

Cllr. Evans asked about roof being hidden behind raised façade? Applicant looked at this issue closely to ensure roof out of view and chose building materials carefully.

Have taken consultancy advice as potentially affected by flooding and feel they have a feasible solution.

127/2021 **MINUTES** - it was **RESOLVED** to approve the minutes of the council meeting held on 21<sup>st</sup> January 2021 and the chairman was duly authorised to sign them.

#### 128/2021 **REPORTS**

- a) Shropshire Council
  - Local Plan Review Cabinet agreed LP wouldn't be considered by Council until middle of July.
  - Riverside development considered by Cabinet 3 weeks ago. Shows bus station gone with housing on the site; concerning and no replacement bus station planned. Consultation after the elections.
  - Crossing on the Caradoc works to start 6<sup>th</sup> April, completion by 9<sup>th</sup> May.
  - Council Tax increase 3.99%, 1% below government maximum; deferred the 1% rise to 2022/3. Predicted overspend of £1 million.
  - Weir Rd and drainage some drains completely blocked. Drain on Orchard Lane running clear and the other drainage seems to be the root of the issues. Cllr. Evans getting a drainage officer to look and suggested parish council asks to. John Bellis in charge of drainage and suggested Cllr. Jones may wish to attend the meeting with SC. Cllr Jones said he saw Richard Knight shortly after the issue with Weir Road he has intimated he would be discussing with colleagues a possible improvement to surface of Orchard Lane. But further loose material without a base to the road could exacerbate the situation further.

Proposal: Application under Section 73A of The Town & Country Planning Act 1990 for alterations to land to increase car sales area and associated improvements

<u>Comments:</u> It was <u>RESOLVED</u> to object as the increased area is for more than 4 cars. If planning is given the number of cars for sale must be limited to 20 and there must be provision within the site for customers to park; vehicles presently park outside the site which compromises the safety of the junction with the Orchard Lane.

3) 21/00924/EIA – Application for the North West Relief Road

<u>Comments:</u> The parish council objects on the grounds of adverse impacts on climate change, disruption during construction, adverse impact on air quality, creation of new rat runs, SC liability for overspend.

The road will not resolve town centre traffic issues and money could be spent on sustainable transport issues and improving other pinch points such as "Dobbie's Roundabout". Alternatives such as re-opening parts of the rail network could be considered.
