31/2223 **MINUTES** – it was **RESOLVED** to confirm the minutes of the Council Meeting dated 26<sup>th</sup> June 2022 as being a true record and to authorise the chairman to sign them, subject to correction of two typos.

#### 32/2223 **REPORTS**

- *a)* Police Report none but noted that a member of the public had reported vandalism at Caradoc Play Area.
- b) Shropshire Council
  - Empty Homes consultation closes September. The parish council noted and supported it
  - Local Plan hearings concluded. The inspectors have queried re if neighbouring authorities were consulted correctly.
  - Targeted support for those needing help with energy available.
  - Integrated Care System came into effect 1<sup>st</sup> July. SC and Health Authority working together
  - Moped hire scheme
  - Financial Plan of SC aiming to save £8.5 million this year, £27.5 million next year due to inflation
  - Economic Growth Strategy
  - Healthwatch changing 2023 onwards
  - £500k investment on Shirehall to allow bottom 3 floors to continue to be used. Top 3 floors have had a prohibition notice issued by Fire Authority
  - Bin collection days may change from November
  - Community lottery being started.
  - Child sexual exploitation Telford SC currently saying Inquiry doesn't affect them but Cllr. Evans and others have challenged as to if any Shropshire children were trafficked.
- c) Youth club committee has met recently. More volunteers are needed.
- d) Village Hall grant applications from the hall for CCTV and new flooring were noted. Annual fund-raising event to be held in Sept. The hall held a bingo night on July 16<sup>th</sup>,

- e) St Thomas PCC Cllr. Bromage said his understanding is he sits on Great Hanwood Relief in Need Charity, which offers grants of up to £150 for people in need.
   Action: It was agreed to write to St Thomas PCC saying the late Graham Lewis was our representative and therefore do the PCC need the parish council to nominate someone else?
- f) Speed Camera WG the police are aiming to start processing data from 1<sup>st</sup> August and taking relevant action. The clerk outlined the initial data reports which show a significant reduction in speed, with 85<sup>th</sup> centile speed being below 32mph.
