b) Shropshire Councillor Report

The LJC had met and supported applications for £1,000 rurality youth funding for each of Hanwood, Ford and Nesscliffe youth clubs but a separate panel had met and recommended each club be awarded £500. The clerk will obtain information on match funding for each club and provide it to Mathew Mead so that the funding allocations can be reviewed. Hanwood Youth Club were congratulated for winning first prize in the category of unsponsored float at Shrewsbury Carnival.

A site meeting had taken place re the condition of Orchard Lane. SC Highways have agreed to do the pot holes at bottom and a quote has been obtained for clearing the drains to see if they could be included in future regular maintenance. The large pothole by the garage has been filled in by the builder.

It was noted that placing a splitter island outside the Shropshire Homes development West of Caradoc View would cause issues with putting in a light controlled crossing. Shropshire Homes have said they will put in a crossing by end of 2018 but not a splitter island. Cllr. Evans has supported this proposal as it will be better than a splitter island. The council supported this also and the clerk will write to Jason Hughes and inform him.

Road works programme – the contractors have applied for permits covering a longer period than the works will take as it is hard to predict exact start date of the work. They will work weekends if needed. SC will write to residents telling them the dates.

Cllr. Evans went to Vine Close – there is a concern that when the church has a funeral people attending park in the access to Vine Close, sometimes on both sides of the road. Clerk to write to the church and ask them to get cones to put down one side of road if is a large event on.

- h) Drainage at land west of Caradoc View Shropshire Homes had responded to an enquiry re drainage during recent heavy rain as follows:

"As you're aware we recently experienced particularly heavy rain that led to a lot of issues across the region.

We are aware that some water did come from the field onto the highway during the rain but are also aware that this has happened previously prior to our development commencing.

Our proposals are to install a drainage system which will take the rainwater from our development site into a storage system being a pond and pipes which will have enough capacity to store the volume of water from the field at the calculation of a 100 year storm event.

The stored water will then be released through the new sewer at a restricted rate to avoid issues 'downstream'.

The drainage system will therefore lead to a huge improvement over the current situation although there may still be instances of water getting onto the highway as the storage solution is for the section of land we are developing only and there is land beyond the site which will still naturally drain overland."

- *j)* Reports of other parish matters
 - (i) Street light by the church and VAS needs replacing.
 - (ii) Light on Oaklands View permanently on reported to Severnside.
 - (iii) Email from Shropshrie Homes asking parish council to maintain open spaces and ponds at land west of Caradoc View development it was agreed to ask Shropshire Homes to calculate a commuted sum based on 10 years maintenance and Landright Services to quote as well. It was agreed to also seek a guarantee for the first 10 years re the attenuation ponds.
 - (iv) Walkabout re EMG Cllr. Evans to organise after the summer holidays. It was **RESOLVED** to apply for £1,000 to cut the hedge on Post Office Lane and clearance of hedges/path along main road.
 - (v) Community Enablement Team it was noted that SC is considering not continuing to have a CET. It was **RESOLVED** to write to the Chief Executive objecting to this and highlighting the value of the team.
